Name of work: - Structural Gazing work for Renovation of Head Office (Specifically 2nd Floor) of Vidyasagar CCB Ltd., at Midnapore, PO: Midnapore, Paschim Medinipur.

Description of works :- Work should be done as per the design and instruction given by Engineer/ authority of the Bank.

Description of Work :

- A) Providing & Fixing structural Glazing** comprising of special type of Aluminum sections by fixing 13.52 mm (6mm clear toughened + 1.52 mm PVB + 6mm clear toughened) laminated glass including all consumables like gasket, sealant etc. : 75 Sqm (Area)
- B) Cleaning & repairing** of Aluminum composite cladding and making proper **lining and providing sealant** etc. The vendor have to bear the cost of staging at their own. : 350 Sqm (Area)
- C) Providing & Fixing of Aluminum composite cladding** comprising of special type of Aluminum sections including all consumables like gasket, sealant etc. : 45 Sqm (Pan Area)

- 4) No advance or running payment shall be made. Payment shall be released after the satisfactory work as mentioned above and providing & fixing of allied works
- 5)No deviation from the specification shall be allowed without prior consent of authority.
- 6)All rubbish and superfluous materials shall be removed from site at the cost of contractor after the completion of work and prior to submission of final bill. Rubbish may be disposed outside of premises.
- 7) The contractor shall make arrangements for storage of material, tools and equipment etc at the site and Bank shall not bear any expenses and risks also on this account.
- 8) The contractor shall observe all necessary precautions at his cost to safeguard the workers during execution of work.
- 9) **85% payment against inspection acceptance delivery and completion** of works and balance **15% will be paid after 12 months of warranty period**. And also that the Payment will be made on successfully completion of work as per work order through account payee cheque or by transfer through NEFT/ RTGS .
