NOTIFICATION

It is notified for information to the **Grade-IV employees** of the Bank that in accordance with the decision of the B.O.D. of the Bank in its meeting dated **30.04.2022**, a **Departmental Examination** will likely to be held to fill up 08 vacancies in Grade-III posts by way of promotion on the basis of **written test and viva** voce conducted by the Co-operative Service Commission, W.B. according to marks as specified below:

Eligibility:-

- (i) The Grade-IV employees who have served the Bank at least for 3 (Three) years as on the date of Notification , will be eligible for appearing at the departmental examination for promotion to Grade-III post of the Bank.
- (ii) The concerned Grade-IV employees shall have the Educational Qualification at least **passed in Madhyamik Pariksha** or its equivalent examination recognized by West Bengal Board of Secondary Education or any other Board recognized by the Govt .

Marks:-

Total Marks for promotional examination, 2022 will be on the following manner:

(i) Arithmetic , (ii) English Grammar & Composition , (iii) General Knowledge on current & Co-operative Affairs .
